

Conditions of participation:

- 1. the organizer of the competition is Flughafen München GmbH, Nordallee 25, 85326 Munich. Participation in the competition is subject exclusively to the terms and conditions set out here.
- 2. persons who subscribe to Flughafen München GmbH's personalized MyAirport newsletter and are at least 18 years of age at the time of entry are eligible to participate. Participation in the competition is voluntary and free of charge.
- 3. Each participant may only enter once in his/her own name. Participation in the competition is only possible in person. Representation by third parties (e.g. sweepstake agencies) or automated participation (in particular with the help of so-called "bots") is not permitted.
- 4. employees of Munich Airport are excluded from participating in the competition.
- 5. entries can be made up to and including 11.06.2023. The electronically recorded date of receipt of the entry declaration data in the system is decisive.
- 6. The winners will be determined by drawing lots from among the participants who have answered the raffle question correctly. The draw will take place on 12.06.2023. The winners will be notified immediately afterwards via the e-mail address provided. The participant is responsible for the correctness of the e-mail address provided.
- 7. With the notification of the prize, the winners are requested to contact us and to provide their address for the dispatch of the tickets by post. If the winners do not contact us within two days to provide the necessary information for the shipment, they will be excluded from the competition and the prize will be forfeited. In this case, it is at our reasonable discretion whether we select another winner or another new winner as a substitute the above provisions will then apply accordingly to them.
- 8. A cash payment, payment in other material assets or exchange of the prize is not possible.
- 9. We can exclude participants from the competition who manipulate or attempt to manipulate the competition and/or the participation process, violate these conditions of participation and/or otherwise unfairly or dishonestly attempt to influence the competition or the execution of the competition.
- 10. The prize consists solely of the tickets for participation in the event offered. We are neither liable for the dispatch of these tickets by mail nor for the actual execution of the event nor for the necessary travel to and from the event of the winner.

We reserve the right to cancel or terminate the competition at any time without prior notice and without giving reasons, provided that this is reasonable for the participants of the competition, taking into account our interests. This applies in particular if, for technical reasons (e.g. manipulation or errors in the hardware/software) or for legal or other reasons, the proper execution of the competition cannot be guaranteed. In this case, we will decide at our reasonable discretion whether the prizes offered will be awarded according to the originally intended procedure or according to another procedure among the participants received up to the time of termination.
- 12. The legal process is excluded.
- 13. Within the scope of the competition, we process the data provided by the participants for the selection of the winners, for contacting the winners and for sending the prizes. After the end of the competition, the data will be stored for 3 years from the end of the calendar year.
